Lab	Repeal Metrology Licensing Provision	ODAFF Lab Services does not do this; need to change law to repeal rules; 35:25-3-1 through 35-25-3-10 are required by statute. The original statutes were found in Title 83 but were renumbered to 2 O.S. 14-1 through 14-7 in 2001. And, the statutes requiring 35:25-3-2 through 35:25-3-4 were repealed that same year. (That's why they're missing from our rules ;)) All this means...we can't revoke this unnecessary set of rules without a statutory change by the Legislature.
