Forty-second Legislative Day, Thursday, April 18, 2024

An Act relating to immigration; providing legislative intent; defining term; making certain acts unlawful; providing penalties; directing law enforcement agencies to collect identifying information and cross-reference said information with certain databases and federal lists or classifications; authorizing the Oklahoma State Bureau of Investigation to collect and maintain certain identifying information; stating legislative finding; providing preemption provision; providing affirmative defenses to prosecutions; making defendants charged with or convicted of certain crimes ineligible for probation, delayed sentencing, or community sentencing; providing for severability; providing for noncodification; providing for codification; providing an effective date; and declaring an emergency.
