
- ► 199,303 students enrolled in AY24.

### **WORKFORCE NEEDS**




- ► By 2031, 42% of jobs in the U.S. will require at least a bachelor's degree.




### STATE EDUCATIONAL ATTAINMENT

### LEGISLATIVE INITIATIVES

Funding Type	Amount Requested for FY2026
Recurring	\$9,260,000

#### ► Strong Readers Act - \$5,500,000

► Funding will support staffing, development of curricular requirements, advisement, assessments, and instruction required to implement the Strong Readers Act.

#### ► Concurrent Enrollment - \$3,760,000

► Funding will support increased participation in the program for junior and senior high school students enrolled concurrently at colleges and universities. Fall 2024 preliminary enrollment data indicates an increase of 10.8 percent in concurrently enrolled students.



### CRITICAL WORKFORCE INITIATIVES

Funding Type	Amount Requested for FY2026
Recurring	\$42,040,000

#### ► STEM & Other Critical Workforce Degrees - \$19,440,000

► Funding will support the production of graduates in STEM and fields of study aligned with Oklahoma's critical workforce needs.

#### ► Nursing & Healthcare Instruction & Workforce Needs - \$10,000,000

► Funding will increase state system capacity to deliver nursing education programs to meet the critical shortage of RNs in the state.

#### ► Adult Degree Completion Outreach & Financial Aid - \$12,600,000

► More than 400,000 Oklahomans have earned some college credit but no degree. The State Regents are committed to creating more efficient pathways to degree completion for adult learners, including the development of micro-credentials, providing financial support, and expanding student support initiatives specifically for the adult learner.



# INSTITUTIONAL EXCELLENCE & STUDENT SUCCESS

Funding Type	Amount Requested for FY2026
Recurring	\$43,700,000

#### ► Performance-Based Allocations - \$25,000,000

▶ Discretionary funding for colleges and universities to address operating obligations, including faculty salaries, risk management, utilities, library acquisitions, equipment, and supplies.

#### ► Student Success & Support Services - \$12,500,000

► Funding will support student access and success through student support services.

#### ► Innovation, Technology & Efficiency - \$2,700,000

► Funding will support development of shared services, including people, processes, and technologies to achieve greater efficiencies within the system.

#### ► Campus Safety, Security & Cybersecurity - \$3,500,000

Funding will support both physical and cyber security measures and the deployment of security controls across networks and platforms required to maintain a safe environment for students, faculty, staff, and visitors.



### DEFERRED MAINTENANCE

FY26 Deferred Maintenance Projects from OCAMP Revised Apportionment .......\$101,250,000 (all colleges & universities)

- ➤ Accelerate distribution of all OCAMP funding in FY26 rather than over the next 3 fiscal year to leverage the purchasing power of these funds more efficiently.
- ➤ Anticipated deferred maintenance uses include:
  - ► ADA compliance requirements
  - Critical infrastructure improvements
  - Heating and cooling systems
  - Roofing projects
