## First Regular Session of the Sixtieth Legislature of the State of Oklahoma

**Fifty-third Legislative Day, Wednesday, May 7, 2025**

## MESSAGES FROM THE GOVERNOR

Advising his approval May 6, 2025, of Enrolled **SBs 95, 497, 742, 890, 942 and 991**.

Advising that on May 7, 2025, Governor's messages were received on **SBs 578 and 940** and were filed with the Secretary of State.

Advising that on May 7, 2025, in accordance with Article VI, Section 11, of the Oklahoma Constitution, **SBs 76, 200, 249, 283, 403, 582 and 600** have become law without the Governor's signature.

Advising his veto May 7, 2025, of Enrolled **SB 465**.

The veto message reads as follows:

May 5, 2025

TO THE HONORABLE PRESIDENT PRO TEMPORE  
AND MEMBERS OF THE OKLAHOMA SENATE  
FIRST REGULAR SESSION OF THE  
SIXTIETH OKLAHOMA LEGISLATURE

### ENROLLED SENATE BILL NO. 465:

Pursuant to the power vested in me by Section 11 of Article VI of the Oklahoma Constitution, I have vetoed Enrolled Senate Bill 465.

Institutions of Higher Education are seeking special treatment when it comes to auctions and events involving alcohol. No other charitable groups—like cancer foundations or local nonprofits—would get the same break this legislation provides. Our laws should apply equally to everyone. In any event, the Legislature should pass a law that removes the limit for all charitable and non-profit organizations.

For these reasons, I have vetoed Enrolled Senate Bill 465.
