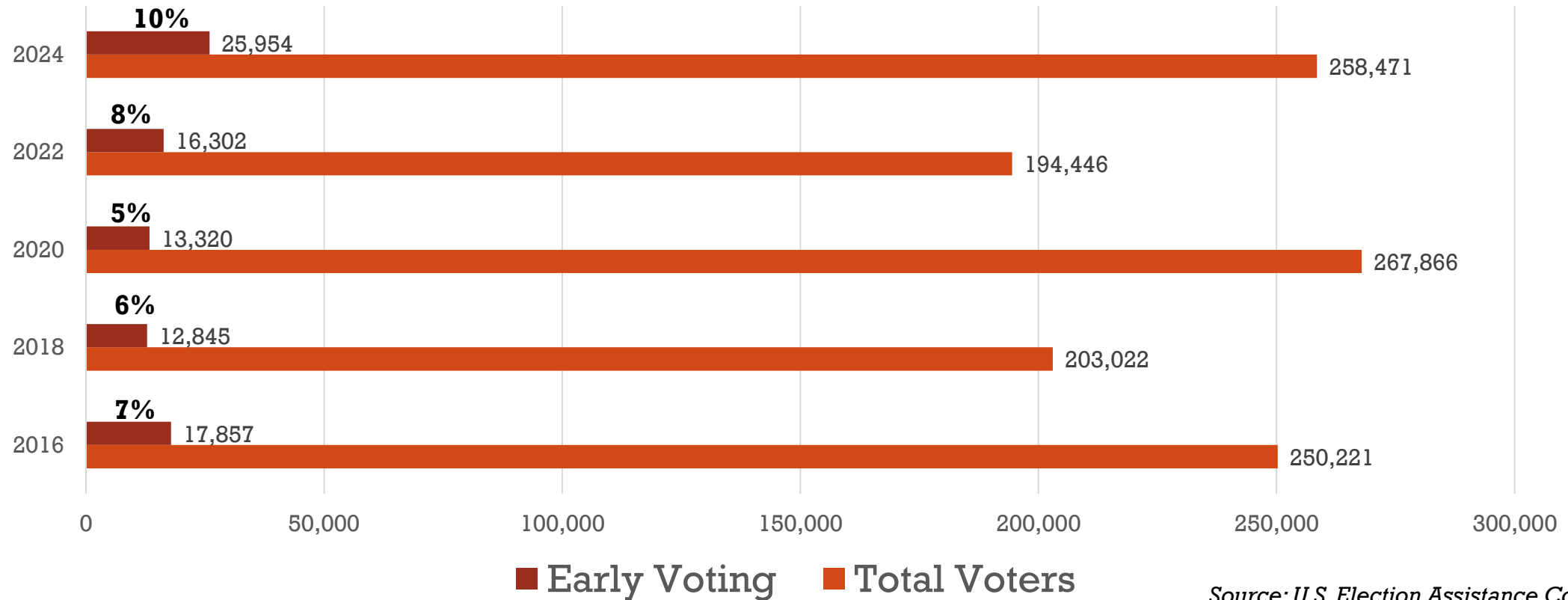
ELECTION DAY

- ❑ Precincts open from 7am to 7pm
- ❑ 251 total precincts in Tulsa County
- ❑ Registered voters are listed in a printed registry, so the number of potential voters is a known factor
- ❑ Number of printed ballots are based on number of registered voters in that precinct
- ❑ Trained poll workers at every polling place (At least one Inspector, one Judge, and one Clerk; larger precincts will require more poll workers)
- ❑ Polling places must be ADA compliant
- ❑ Polling places must have easy access to voters
- ❑ No network accessibility is needed

EARLY VOTING

- ❑ Locations open 8am to 6pm
- ❑ No printed registry
- ❑ Number of ballots needed are unknown (400,000 registered voters in Tulsa Co.; voters are allowed to vote at any location) Ballots for local entities must be considered
- ❑ Trained Absentee voting boards plus additional personnel must be present at every location including the Election Board
- ❑ Polling places must be ADA compliant
- ❑ Polling places must have easy access for voters
- ❑ Physical security (Sheriff Department) is required
- ❑ IT security (Secure network accessibility necessary)

EARLY VOTING SITE SELECTION

- ☐ Easy access to major highways or thoroughfares
- ☐ Parking for several hundred voters must be available
- ☐ Ample interior room for equipment, staff, and long lines
- ☐ ADA accessible
- ☐ Venue must be available for four to five days

PERSONNEL PER SITE

- ❑ The following are estimates per location based on prior Early Voting experience in Tulsa County:
 - We plan to request fourteen (14) In-person Absentee Voting Boards, for each Early Voting location which, by law, must consist of two trained personnel from each major party (28)
 - Site supervisor (1) (CEB expense)
 - Supplies/ballot runner(s) (CEB expense)
 - Crowd control/Set up staff (7) (CEB expense)
 - IT personnel (1-2) (CEB expense)
 - Sheriff's department on site to provide security (1, minimum) (CEB expense)
 - Daily cleaning crew (1) (CEB expense)
 - EMSA on standby (CEB expense)

COUNTY RESOURCES NEEDED

- ❑ Information Technology
 - Secure network and establish a firewall
- ❑ Tulsa County Sheriff's Office
 - Security must be on site and must accompany ballots back to the Election Board at the end of the voting day
- ❑ Tulsa Area Emergency Management Agency
 - Crowd control planning
 - Road barrier planning
- ❑ Tulsa County Highway Maintenance Office
 - Physically places barriers
