The Commission's mission, powers and duties are set out in its enabling act as enacted by the Legislature. Title 3A O.S. § 604.2(A) provides:

“The mission of the Oklahoma State Athletic commission shall be to expand and promote existing combative sporting events in Oklahoma and to actively work to bring new combative sporting events into Oklahoma.”

Title 3A O.S. § 611 further states:

“Before issuing any license or sanctioning permit, the Oklahoma State Athletic Commission shall consider the following in order of importance:

1. The preservation of the safety and health of the participants;
2. The best interest and welfare of the public; and
3. The best interest of combative sports in general.”

Proposed Mission Statement in House Bill 1364- “The mission of the Oklahoma State Athletic Commission shall be to promote, preserve and protect the health, safety and welfare of combative sports participants and the general public through the effective regulation of combative sports in the State of Oklahoma, while fostering an environment that expands existing combative sports events and brings new events into the state.”

Pursuant to 3A O.S. § 604.1, the Commission consists of nine members appointed by the Governor with advice and consent of the Senate. The members serve three-year terms and shall have the following qualifications:

Two members shall have experience as a professional combative sports practitioner other than a wrestler (i.e., boxer, kickboxer or MMA fighter) or experience in combative sports promotions other than wrestling;

One member shall have experience as a professional wrestler or in wrestling promotions;

One member shall have experience in sports medicine;

One member shall have experience in the cable television business;

Four members shall represent the public at large.

Oklahoma State Athletic Commission

By statute the Oklahoma State Athletic Commission is provided administrative support from the Oklahoma State Department of Health for which services the Commission pays a fee. All modernization efforts undertaken by the Oklahoma State Department of Health have also been undertaken by the Commission. This has led to a slight additional cost to the Commission.

What steps has the agency taken to cut costs and/or eliminate waste? Are there efforts that have been successful which you believe could serve as a model for other state agencies seeking to keep costs minimal?

Use of State Vehicles when possible

No. Under federal law, all professional boxing events must be regulated by either a State or tribal commission. 15 U.S.C. §§ 6301-6313. Pursuant to the Oklahoma State Athletic Commission Act (3A O.S. §§ 601-624), the Commission also regulates professional kickboxing, professional wrestling, and professional and amateur MMA. In issuing licenses and permits, the Commission exercises the police powers of the State. There is no private entity that licenses combative sports participants.
