MODERNIZATION EFFORTS:

In 2012 the OAB took the lead in the State of Oklahoma for modernizing the licensing process of licensing agencies by becoming the pilot agency for the implementation of the AMANDA licensing system. The system provides for efficiencies in processing and accountability of each staff person and their duties. Additionally, the OAB began the process of becoming a paperless agency by implementing an imaging system that will be integrated into the AMANDA system.

The agency is embracing the use of technology to improve responsiveness to its customers. The elimination of regular mail and replacing with e-mail of bulletins and routine informational correspondence has reduced the postage, paper and manpower cost normally associated with mailing of the past. The imagining initiative is reducing storage space requirements and improved accessibility.

CORE MISSION:

The OAB is not required to provide services outside its core mission.

PRIVATE ALTERNATIVES:

There are no private sector services which perform the duties of the OAB. The Board is a member of the National Association of State Boards of Accountants which does offers some services which are performed by the OAB. The OAB has contracted with NASBA to perform some of these services which are more cost efficient for the OAB. Remaining services that NASBA offers the OAB performs faster and more efficiently than does NASBA
