Secretary Reese serves as a cabinet secretary to the Governor as well as the Commissioner and President of the Oklahoma Board of Agriculture. The Board of Agriculture members are appointed by the Governor. The current members are: Jay Franklin of Vinita, OK; Karen Krehbiel of Hydro, OK; Joe Farris of Taloga, OK and Ed Hurliman of Broken Bow, OK.

All of the board minutes from the Oklahoma Board of Agriculture are posted on the agency website. All Board of Agriculture members attend monthly meetings unless Secretary Reese is notified in advance. The Board of Agriculture has a very strong attendance record of 99%.

### **Modernization Efforts:**

- Conversion to PeopleSoft Time and Labor –completed
- Information Technology Consolidation with OSF per HB 1304 –completed
- Shared Services for Payroll –completed
- Online Licensing –nearing completion- first annual online license renewal completed December 8, 2015

What steps has the agency taken to cut costs and/or eliminate waste? Are there efforts that have been successful which you believe could serve as a model for other state agencies seeking to keep costs minimal?

- ODAFF is in the process of converting to Alternative Fuel Vehicles to reduce fuel costs
- AEMS division has 2 soil scientists whose salaries are paid by private industry instead of state funds. There are also 2 employees whose salaries and travel are reimbursed by the city of Tulsa for work in the Eucha-Spavinaw watershed.
- AEMS division has increased territories for inspectors due to retirements. One inspector was given 52 additional facilities to inspect in 2011.
- Forestry Division has increased inmate labor at the Goldsby regeneration farm which equals a savings of 100K on temporary labor.
- Divisions have converted to electronic mailings to save costs.
- Market Development and Animal Industry Division have shared the cost and responsibilities of an Ada livestock market reporter instead of filling the vacant position
- Forestry Division has developed relationship with NRCS and Bureau of Reclamation to offset decreases in state funding
- Consumer Protection Services Division developed online monitoring of continuing education for pesticide applicators
- Agency has sold surplus property
- Agency has re-furbished 15 work stations with surplus property
- All divisions have reduced travel expenses
- The forestry division no longer does cost share work with landowners
- The forestry division has suspended its water quality forestry work and watershed improvement programs
- The forestry division now has only 4 people covering the 59 counties in central and western OK.

• The ODAFF pesticide laboratory developed a new analytical method that increases the number of samples tested a day from 6 samples to 150 samples. This method cut costs by 95% and EPA adopted the method for use in all FIFRA labs nationwide.
